

## **NOTICE TO CONTRACTORS**

### **PEDESTRIAN IMPROVEMENTS FOR HORSESHOE POND LANE & NORTH MAIN STREET**

The Purchasing Division, City Hall, 41 Green Street, Concord, NH, 03301, will be receiving sealed bids for Pedestrian Improvements on Horseshoe Pond Lane, and North Main Street.

Complete sets of Bidding Documents may be obtained the Purchasing Division upon payment of Ten Dollars (\$10.00) per set. This deposit will be non-refundable. Sets will be mailed to bidders for an additional non-refundable mailing fee of five dollars (\$5.00) per set. Checks are to be made payable to the City of Concord.

Each bid must be accompanied by **BID SECURITY**, payable to the City of Concord, New Hampshire, in the amount of ten percent (10%) of the total bid. The **BID SECURITY** must be either a certified check, cash, check drawn by a New Hampshire bank, or bid bond for and subject to the conditions provided in the Instructions to Bidders.

Separate Performance and Labor/Materials (Performance) Bonds in the total amount of the contract shall be required of the successful bidder to guarantee the faithful performance of the contract and the payment of all labor and materials used in the work.

The City of Concord and or the owners reserve the right to reject any or all bids or any part thereof, to waive any formalities, informalities, information and/or errors in the bidding and to accept the bid considered to be in the best interest of the City. Failure to submit all information called for may disqualify the bid.

Each bid shall be submitted on the Bid Form supplied by the City of Concord in a sealed envelope clearly identified with the Bidder's name and address. The sealed envelope should be plainly marked:


The Schedule of Prices section of the Proposal Form shall be completed showing the Unit Price and Total Price for each item, and a Grand Total for all items.
